## **Restoring Hope Through Legal Assistance**

Jamie and Adam came to Between Friends concerned about their 16 year old daughter, Marissa. Marissa was pregnant and had been dating a 17 year old boy that goes to her high school for a few months. There were a number of times that Jamie and Adam came home to find bruises on their daughter. Marissa had tried breaking up with her boyfriend a number of times, but he would repeatedly go to her house and harass her until they got back together. Then one day, Marissa's boyfriend attacked her on the bus. He was sent to the principal's office where he threatened her and said that she would never have his baby. The school then called the police, the boyfriend was arrested, and he spent the night in jail.

After the bus incident, Marissa was afraid to go to school. Jamie had called the school social worker to work out an arrangement to change buses or even schools, but the social worker did not call her back. When she came to Between Friends, our Court Advocate worked with Jamie and Marissa to secure a two-year Order of Protection, and the judge required that Marissa be transferred to another school. Now, her boyfriend will be arrested again if he comes near Marissa or her school any time in the next two years. Jamie and her daughter were both extremely relieved that Marissa could now attend school safely.

The story of Marissa's abuse is deeply troubling and unfortunately all too common.

Associate Judge Samuel Betar of the Rolling Meadows Courthouse explains, "We see a lot of sad situations. We are seeing 1-2 cases each month of high school girls who are coming to the courthouse to ask for Orders of Protection against their boyfriends. We are also seeing more elderly parents who are seeking Orders of Protection against their children. This is difficult emotionally for a parent to make public the problems they are having with a child."

The elderly, teens, and other domestic violence victims seek legal protection from their abusers by filing for an Order of Protection (OP). An OP is one of the legal remedies to help keep the abuser away from the victim and/or their children, grant the victim possession of their house so that she or he doesn't have to move into a shelter, require the abuser to pay child support, or insist that the abuser receive counseling, among other things.

According to The Mayor's Office on Domestic Violence, of the 18,578 calls to the City of Chicago Domestic Violence Help Line in fiscal year 2007, the most requested service by callers in crisis, with the exception of shelter, is legal assistance.

Judge Daniel Sullivan who has worked as a Domestic Relations Judge for 16 years explains, "Certain days are overwhelming with the number of people needing assistance. Judge Betar and I often discuss how thankful we are that the court advocates are

## The Executive Director's Corner

Dear Friends,

### **Our past six months have been busy ones!**

Between Friends began offering services in 1991 through our 24-hour toll free **Crisis Line**. In recent years the majority of callers began seeking support and resources during regular business hours through our business lines. An agency task force was charged with examining this issue and making recommendations. Over the summer, we restructured this service by partnering with the **Chicago Metropolitan Battered Women's Network**. During the overnight hours and on week-ends, our line is now transferred to their statewide Domestic Violence Helpline. This effective collaboration has allowed us to reallocate our staff and volunteer resources to assist victims and their families in other important ways.

Our **Women and Children's Program** held a retreat this summer to review our service delivery model. In particular, we wanted to streamline our intake process and assess our group services to make it easier for women to get help and avoid a waiting list. We

are offering a number of groups for women and children on healthy relationships, self-care, parenting, and financial literacy which helps women understand financial abuse, develop a budget, and secure better credit. This year we will also offer Parent-Child Psychotherapy to help prevent trauma from being transmitted from parents to their children ages 0 to 5.

Last year, our **Relationship Education: A Choice for Hope (REACH) Program** worked with over 5,600 youth and 250 adults. During that year, we conducted a number of focus groups to look at trends in youth violence and seek input for future curriculum development. Our violence prevention experts, including Dr. Paul Schewe of UIC, made a number of recommendations: increase the scope and depth of sessions on healthy relationships, spend more time with youth through longer term programming, and increase youth involvement in program implementation.

We also met with over 233 youth and asked them what they needed in order to develop healthy relationships and avoid abusive ones. They said they wanted more information about how to choose a dating partner, respond

to abusive behavior, and break up with a partner. As a result, we have expanded our **Discussing Relationships in Early Adolescence Makes Sense (DREAMS)** curricula to include three new sessions to address these issues. We are now in 7th and 8th grade classrooms for nine weeks instead of six, making a more significant impact on these students and their teachers who often incorporate themes from our curricula.

The staff continues to do an amazing job of developing programs to address the priorities of those who seek our services. This is in spite of the 29% cut in Victim's of Crime Act funds and the hold put on 3% of our funds coming from the Illinois Department of Human Services. **Due to this lack of funding, 37% fewer individuals will be able to receive our intervention and prevention services this year.** With that said, I am encouraged by the possibilities that come with new government leadership and look forward to a better future for our families!!

here." Despite the tremendous need for legal services for domestic violence victims, limited funding causes many to face hearings seeking an OP alone. In fact, Between Friends has to turn away an average of 27 individuals each month because we do not have enough advocates to work with all of the victims who come to seek our help. Furthermore, Between Friends is the only agency that provides civil legal advocacy at the Rolling Meadows courthouse.

For over 600 individuals a year, Between Friends' Court Advocacy Program provides bilingual Spanish/English legal assistance in Cook County District One (Chicago) and District Three (Rolling Meadows) Courthouses. Our court advocates help victims understand

their legal rights, secure OP's, do safety planning, feel less intimidated, and support them in the court room. According to Colleen Norton, Between Friends' Senior Court Advocate, "For many clients we see, coming to the courthouse is their first step in getting out of an abusive relationship. The majority of our clients have decided they want to leave their relationship before they come to see us."

Friends also facilitates free legal clinics twice per month, which connect domestic violence victims to volunteer attorneys in private one-on-one consultations. These attorneys assist victims with issues such as: divorce, custody, visitation, and child support. "People are often feeling hopeless and overwhelmed by

the legal process. I think by giving them legal direction, we can help them feel empowered, less afraid, and even regain hope," says Attorney Larry Manassa, who volunteers at Between Friends' legal clinics.

You can help make a difference in the lives of survivors like Marissa. Write a letter to request that the governor restore funding for domestic violence services to Illinois' state budget. Volunteer your time as a pro-bono attorney or assist in the courtroom with our advocates. ## Domestic Violence Awareness Month

October marked the 21st anniversary of Domestic Violence Awareness Month (DVAM). The first observation of DVAM in 1987 evolved from a Day of Unity which was intended to connect advocates all across the country who worked tirelessly to end domestic violence. Eventually that day grew into a full week where the purpose was to hold a range of activities at the local, state, and national levels in recognition of the issue. Now an entire month is dedicated to bringing domestic violence to the forefront.

Throughout the years, DVAM has expanded. It has grown to celebrate the strength of women who have survived domestic violence as well as honor those women who died at the hands of their abusers. We also take this time to remind ourselves of the work that remains to be done to prevent women from facing abuse.

As many of you know, Between Friends kicks off DVAM each year through our event called **"Light up the Lakefront"** on October 1st. At Oak Street Beach, volunteers and staff light 3,000 candles to honor the thousands of women who have been killed by their abusive partners. It is a moving and reverent event.

Prior to the luminaria this year, we held a reception at the home of Board Member, Terry Rose Saunders, overlooking Oak Street Beach. The beautiful view of the beach was enhanced by Ruth G, a domestic violence survivor, who shared her story of courage and strength with the guests. This year we were excited that **Marion Brooks** and **LeeAnn Trotter** from NBC 5 and **Majority Leader Barbara Flynn Currie** from the State House of Representatives were among the guests who attended.

Friends also collaborated with **Fourth Presbyterian Church's Terry Stumpf**, Director of the Center of Whole Health, and the **Women@Fourth Connect** to raise awareness of domestic violence through tying purple ribbons outside the church on Michigan Avenue. Passersby on this prominent street stop to admire the ribbons and read about their significance from the plaque the church places in front of the trees. Additionally, Friends participated in a Vespers service held on October 19th to honor domestic violence victims and also provided information for the October advocacy table at Fourth Presbyterian to help educate church members about domestic abuse.
